## Updates and Reminders:

## 1. Important Update: H5 Avian Influenza Preparedness and Respiratory Season Reminder

Earlier this month, Canada's first case of H5 avian influenza, commonly known as avian flu or bird flu, was identified in the Fraser Valley. A teen has tested positive and is currently being cared for at BC Children's Hospital.

While H5 primarily affects birds and non-human mammals, it has, in rare cases, infected humans through close contact with infected animals. Symptoms may range from mild respiratory issues to severe

conditions such as pneumonia. Children, particularly those with underlying health conditions, may be more vulnerable to complications.

There have been no further cases identified at this time. <u>Learn more from Provincial Health Officer Dr.</u> Bonnie Henry.

The BC Centre for Disease Control provides a <u>comprehensive overview of avian influenza</u>, including public resources and links for additional information. This is a valuable resource to share with families seeking background information.

Keep yourself safe during viral respiratory season by reviewing the respiratory season reminders.

#### 2. Respiratory Season Reminders

As we enter the viral respiratory illness season, medical staff are reminded to follow key precautions and guidance designed to protect staff, patients and families from preventable infectious diseases.

Make it a priority to:

- Follow infection prevention and control measures for your site and continue to make <u>point-of-care</u> <u>risk assessments</u> a routine practice.
- Stay home when sick and only return to work once you are well enough to do so
  - o Refer to the provincial <u>Return to Work Guidance</u> for further details on exposure management for health-care workers with viral respiratory illnesses, or connect with your leader.
- Medical staff are encouraged to get immunized.
  - o You can sign up for influenza and COVID vaccines through the GetVaccinated platform.
  - o Staff can attend any regular PHSA immunization clinic to receive their influenza vaccine. <u>View the schedule and book your appointment</u> using the Janeapp.
  - o Peer immunizers are also available to provide vaccines to their colleagues at select sites across PHSA. Check with your leader for availability.
  - Use the <u>provincial self-reporting site</u> to self-report your influenza protection choice. Make sure you are logged into a health authority networked computer to access the self-reporting site.
- Practice consistent hand hygiene.

#### 3. Privacy, Confidentiality, Social Media, and Media Response Guidelines

This is a reminder of the key responsibilities regarding patient privacy, confidentiality, appropriate use of social media, and responding to media inquiries. Adherence to these guidelines is essential for upholding the professional standards and trust essential to our work.

#### Privacy and Confidentiality

• Access to patient information should be strictly limited to what is necessary to perform specific duties. Patient information should only be shared with authorized personnel directly involved in care.

- Discussion of patient information in public areas or with anyone not involved in the patient's care is strictly prohibited, as it compromises both privacy and trust.

#### Social Media Use

- Social media platforms are valuable communication tools, but sharing any information related to patients, even without identifiers, can lead to privacy breaches and reputational risks.
- Work-related information should not be shared on personal social media accounts, as actions on social media reflect directly on professional standing and the organization's reputation.

- Staff are reminded that any media inquiries should be redirected to the Communications & Engagement Department, as they are equipped to provide appropriate responses on behalf of the organization. If during regular business hours, please refer the media outlet/reporter to the communications team for your program or to the PHSA after hours line outside of core business hours.
- PHSA's after-hours line (778-867-7472 phone only; no text) has two primary functions:
  - o To provide access for journalists and government communications to reach the PHSA communications team after hours (until 10 pm daily and on weekends 7 am 10 pm)
  - o To provide 24-hour access for PHSA staff in urgent or emergent situations with our programs and services.

# 4. Dr. Eric Webber Named Interim CMO at BC Children's Hospital and BC Women's Hospital + Health Centre

As Dr. Jana Davidson's term as Chief Medical Officer (CMO) at C&W concludes in December 2024, recruitment for her successor is well underway, with a permanent CMO anticipated by summer 2025.

Dr. Eric Webber will step into the Interim CMO role starting January 1, 2025, with a transition period beginning December 1, 2024. Dr. Webber, a pediatric general surgeon at BC Children's Hospital since 1997, brings extensive leadership experience, including roles as division head of Pediatric General Surgery and chair of PHSA's Health Authority Medical Advisory Committee (HAMAC).

## 5. CST Cerner: Advancing Quality and Safety in Electronic Health Records

PHSA has recently launched EHR Quality and Safety, a new program within Medical Informatics focused on enhancing the quality and safety of Electronic Health Record (EHR) use. This program, launched in partnership with PDHIS and the Integrated Quality and Safety Portfolio, leads by example, emphasizing proactive monitoring of CST Cerner functionalities that directly impact patient care and preventing unintended safety events through agile system improvements.

The need for this program became clear after recent issues with failed distribution of clinical documentation to community providers. These issues, caused by mismatches between the note signatory and document placement location, prompted a swift response from a multi-disciplinary team at PHSA, including members of Health Information Management, Quality and Risk, Clinical Informatics, and executive medical leads. The team worked swiftly to resolve the backlog while evaluating each case in collaboration with providers to ensure no patient harm occurred due to delayed documentation.

This proactive approach sets a new standard for tracking and addressing potential risks, marking a significant advancement in EHR-related quality and safety across our three partner health authorities — Vancouver Coastal Health, Providence Health Care, and PHSA.

In his acceptance speech, Dr. Seethapathy emphasized the important role of psychiatry in responding to the drug overdose crisis, and the importance of improving access to psychiatric services: "Access, access, access. If you have timely access, and quality access, then things can get better and be saved much earlier on up-stream. It is about advocating for the right resources, the right human resources, and the right system to support psychiatrists in their work."

The newly developed Office for Medical Staff Safety and Wellbeing (OSWELL) at PHSA invites qualified candidates to apply for the role of peer support physician. The peer support physician will provide psychological and procedural support to medical staff and residents facing complaints or critical patient safety event reviews (CPSER). This role emphasizes structured peer support, distinct from counseling, mentoring, or informal peer relationships, focusing specifically on emotional support and assistance in navigating the relevant processes for medical staff. In this role, you'll proactively reach out to affected medical staff, offering a compassionate, confidential listening ear and connecting them with additional resources as needed.

If you are a physician with a commitment to creating a safe, respectful work environment and can offer psychologically safe support, you are encouraged to apply.
