Block and Slide Retention Guidelines

Retention time is calculated from the date the specimen is received. It applies to all patients, regardless of patient age. There is no longer a requirement to retain blocks and slides for an extended period when the patient is under 19 years of age. Retention time can be determined by the pathology site based on specimen viability, storage capacity and clinical need.

Surgical Pathology		
Embedded blocks	20 years	
Slides	20 years	
Cytology (gyne/non gyne)		
Slides (negative-unsatisfactory)	5 years	
Slides (positive, any abnormality ≥ ASCUS)	20 years	
Fine-needle aspiration slides	20 years	
Blocks	20 years	
Autopsy (hospital and coroner)		
Embedded blocks	10 years	
Slides	10 years	
Frozen Tissue Blocks		
Muscle biopsies for enzyme testing	5 years	
Skin biopsies for direct immunofluorescence testing	5 years	
Renal biopsies	10 years	
Heart biopsies	10 years	

Applies to:

- Embedded blocks
 - Paraffin/plastic embedded tissue blocks
- Slides:
 - glass slides generated from tissue blocks
 - glass slides generated from original specimen (frozen section, smears, touch preps, cytospins, thin prep, mounted filters)

Does not apply to:

• Tissue section slides produced using procedures that generate an unstable end product e.g. fluorescent in-situ hybridization (FISH)
